Mr. Moss called the regular meeting of the Quality & Safety Committee to order at 10:04 a.m.

I. Approval of Minutes – October 25, 2016

The minutes of the October 25, 2016 Quality & Safety Committee Meeting were approved as presented.

II. DISCUSSION ITEMS

A. Population Health - Dr. Chehade

Dr. Chehade stated that it is very important for Population Health to have a tight relationship with Quality so that they can be aligned and work for the same goals. Regular monthly meetings have been set up to move both parts. Population Health also works with government programs regarding Payment Reform, Clinical Practice Guidelines, Knowledge Management, Quality Improvement, Continuous Practice Transformation and Patient Engagement and Community Involvement. Population Health is concerned about the health of populations and not individuals which elevates the care for everyone.

В. Performance on 2016 S&Q Goals - Matthew Kaufmann

Mr. Kaufmann discussed the Performance Goals for Safety & Quality for 2016. Population Health had nice improvement, Cdiff performed the same as last year but is the best in the State, VAP (Ventilator Associated Pneumonia) decreased from last year, MRSA (Methicillin-resistant Staph aureus) had a spike but met annual target, CLABSI (Central Line Associated Blood Stream) met target, CAUTI will meet our goal. Patient Safety Indicators (PSI) impact the Star Rating and it saw significant improvement. 30-day readmissions are continuing to trend down and work is still needed for Sharp Injury and Order Set Utilization.

C. The MetroHealth Quality Institute – Dr. Alfred Connors & Matthew Kaufmann

The Accreditation Oversight Committee, Patient Quality Risk Safety and Compliance (PQRSC) Committee, Essential Services Quality Improvement Committee and the Clinical Quality Improvement Committee report to the Executive Quality Oversight Council who then reports to the Board of Trustees Quality & Safety Committee Meeting.

 - 4. Achieve excellence compared to national benchmarks
