## Attachment A

### Core Terms for a Three-Year Collective Bargaining Agreement Between The MetroHealth System and Ohio Patrolmen's Benevolent Association ("OPBA")

#### Economic Terms

- Wages: 2019 = special market adjustment raising Patrol Officer start rate to \$21.00 (\$23.00 for those who maintain a Peace Officer Certification)  
2020 = 2.5% increase  
2021 = 2% increase
- Increased hourly premium for attaining/maintaining Peace Officer Certification from \$1.00 to \$2.00, to incentivize achievement of the certification
- New, streamlined wage step chart with elimination of Year 4 wage step, enabling Patrol Officers to reach the top rate faster, to enhance recruitment and retention
- External lateral hires may be hired at rates higher than the start rate, to enhance recruitment
- Healthcare/Insurance:
  1. The Union agreed to MetroHealth's new medical benefits plan design, with no point-of-service charges (deductibles, coinsurance, and copays) for covered services from MetroHealth providers.
  2. Effective Jan. 1, 2020 – New plan design will be implemented.
  3. Effective Jan. 1, 2020 -- New bi-weekly premium rates for the various tiers will be as follows, which represent more equitable cost-sharing across the tiers:

	Existing per-pay premium rate, which will continue for 2019	Premium change effective 1/1/20, which will apply through 2021
Single	\$70	\$80
Ee + spouse	\$100	\$135
Ee + children	\$95	\$120
Family	\$110	\$160

- Other Core Economic Terms:
  1. *MetroHealthy wellness incentive*: During the three-year agreement, MetroHealth agrees to maintain a wellness incentive program. For the 2020 incentive (which will be based on wellness activities completed in 2019), incentive amounts will be available at \$200/\$600/\$800 levels for employee activities, with additional \$100/\$200/\$300 incentive levels available for wellness activities of an employee's spouse/child(ren).

### **Operational Terms**

- Title changed from “Patrolman” to more inclusive “Patrol Officers”
- Elimination of option to receive compensatory time in lieu of overtime payments (resulting in elimination of a manually administered program)
- Efficiencies in processes regarding shift bidding and vacation selection
- Efficiencies in processes regarding end-of-year sick time and holiday time cash-out elections
- Revision of shift differential provisions such that shift differential premiums will be paid only for actual shift-differential hours (currently, Patrol Officers incidentally can be paid shift differential for daytime hours)
- Incorporation into the Collective Bargaining Agreement of the currently active Memorandum of Understanding between the parties enabling management to schedule 10- and 12-hour shifts
- Management agreed to participate in informal labor-management committee meetings to discuss the following issues raised by the Union: weekend scheduling/lunches at satellite locations; processes around uniform purchasing; and processes around physical fitness testing
