

On December 24, 2010, our son, Kyle, had a bad sled riding accident. He was 17 at the time and broke every bone in his face. Kyle spent three weeks in the hospital. He saw doctors from orthopaedics, trauma, neurology, oral and maxillofacial surgery and ophthalmology.

Our home is 165 miles away from Cleveland, and we did not want to leave our son's bedside. We took advantage of the free snacks in the Family Room and used the computers to pay bills online.

In 2011, Kyle was admitted five times for surgeries or complications from the accident. Each time, the Family Room was a lifesaver. When family and friends came to visit, we used the Family Room to meet. From the room, you look out over Cleveland and realize there is another world out there, and things will get better.

Things did get better for us. Kyle has completely recovered and is in his senior year at Minerva High School. We are truly grateful for the excellent care we received at MetroHealth and that the Ronald McDonald Family Room was there for us.






## Philanthropic Attainment




## 2011 Funding Sources




## Planned Giving
