### 2019 Population Health Research Institute (PHRI) Annual Report to The Metro Health System

As the Founding Director of the MetroHealth Population Health Research Institute (PHRI) in 2020, I am excited to share our 2019 annual highlights from the three Centers which currently comprise PHRI: the Center for Health Care Research and Policy (CHRP), the Center for Reducing Health Disparities (CRHD), and the Center for Clinical Informatics Research and Education (CCIRE). While we are currently in the strategic planning process for PHRI, our vision is to be the nation's leading population health research institute. Our evolving mission is to reduce disparities and improve health within the communities and populations in our region and nationally through innovation, education, and collaboration.

### **Grants, Presentations, Awards**

Our 2019 activities have positioned us well as we chart our course during unprecedented times. In 2019, the 16 core faculty within the 3 centers were Principal Investigators (PIs), site PIs, or co-PIs on 22 active grants totaling over \$18 million dollars to The MetroHealth System, with 6 new grants in 2019 (See Grants Table, and additional research highlights below). Beyond active research grants, the core faculty and senior scholars published 38 peer-reviewed publications in 2019 with publications in high impact journals such as Chest, Hypertension, American Journal of Medicine and more. Several faculty also contributed to Dr. Perzynski's 2019 published book entitled "Health Disparities: Weaving a New Understanding through Case Narratives". Our core faculty and senior scholars gave 114 presentations in 2019, with 24 of these as invited national presentations enhancing the visibility of The MetroHealth System and Case Western Reserve University (CWRU) (See Abstracts and Presentations Lists). Faculty have received over 10 awards or achievements in 2019 including CWRU teaching awards and recognition for outstanding research contributions (See Awards, Promotions and Milestones Table).

#### **Education and Workforce Development**

We continue to contribute to the development of a pipeline of population health researchers. CCIRE Director Dr. Kaelber added 2 new fellows to the joint CWRU and MetroHealth Clinical Informatics Fellowship program in 2019. They enrolled their first ever 2 students in the PhD program in Biomedical and Health Informatics at CWRU where Dr. Kaelber and the CCIRE faculty continue to help support the PhD (and MS and Certificate) programs at CWRU. PHRI investigators mentored over 65 trainees from a variety of areas within and outside The MetroHealth System (with over 20 trainees from CWRU including KL2 scholars and over 20 trainees from The MetroHealth System including MetroHealth Baldwin-Wallace MPH students) (See Trainees Table). In addition, many of our core faculty continued to teach in key courses at CWRU in 2019 including but not limited to: Design and Analysis of Observational Studies led by Dr. Love, PHRI Director of Biostatistics and Data Sciences; Introduction to Clinical Research Scholars Program led by Dr. Einstadter; Health Disparities led by CRHD Co-Director Dr. Sehgal; and Qualitative and Mixed Methods in Public Health led by Dr. Perzynski.

#### Service

Our core faculty have also served in over 100 critical service roles for The MetroHealth System, CWRU, professional organizations, the community, and the nation in 2019 (Service Roles Tables). Key national service roles by PHRI investigators include serving on the Department of Health and Human Services National Clinical Care Commission to develop a report to Congress advising on gaps in federal programs and policies for adults with diabetes, the National Quality Forum Perinatal Committee, advisory roles for

the Epic Systems Corporation, Past Chair for the Group on Educational Affairs within the Association of American Medical Colleges, NIH and AHRQ study section members, and journal editors and reviewers. Over 30 roles related to service to The MetroHealth System including research committees, The Green Team, clinical and service line roles, population health innovations institute and quality improvement committees. Key community service roles include engagement and leadership within regional and statewide health improvement collaboratives (e.g., Better Health Partnership, Health Improvement Partnership Cuyahoga) and board members of community groups such as Connect Your Community, Policy Matters Ohio, and Community Development Corporations.

### Selected research project and collaborative highlights from 2019 include:

- 1. Engaging with communities to reduce health disparities. CRHD Co-Director Sehgal continues to lead a center grant entitled "Involving Communities in Delivering and Disseminating Health Disparity Interventions". Main activities within the Center grant include: two randomized controlled trials, a pilot grant program, a community oversight committee, and a health disparities graduate course. The pilot grant program has funded 10 investigators thus far, including 2 from MetroHealth. MetroHealth investigators are Vanessa Maier who is evaluating the impact of MetroHealth's school health program on emotional and social outcomes and Milana Bogorodskaya who is studying barriers to HIV pre-exposure prophylaxis use in Cleveland.
- 2. Statewide collaboration to improve hypertension and address social determinants of health. MetroHealth PHRI investigators in collaboration with CWRU SOM co-lead a Medicaid-funded statewide cardiovascular health collaborative (Cardi-OH) and quality improvement project focused on expanding primary care capacity to manage hypertension and address the social determinants of health. Based on results of this statewide effort including improvements in blood pressure control by 14.7% in 8 primary care practices across the state, we secured new funding in 2019 to expand our focus to addressing diabetes and social determinants of health in 22 new primary care sites across the state (2 pilot primary care sites from MetroHealth). We have purposefully aligned and integrated efforts with primary care, specialty care and the Population Health Innovations Institute at The MetroHealth System so best practices from this pilot can be spread broadly across The MetroHealth System to improve diabetes outcomes.
- 3. Regional efforts to identify and address social needs across the lifespan. PHRI and CHRP Director Dr. Bolen collaborates with 2 regional health improvement collaboratives in our region (Better Health Partnership and Health Improvement Partnership-Cuyahoga) in a Center for Disease Control and Prevention funded Racial and Ethnic Approaches to Community Health (REACH) grant. Dr. Bolen and Mr. Lever lead a program within the grant linking kids with overweight/obesity and asthma as well as linking adults with uncontrolled hypertension to community resources for health improvement at 3 clinics in the region (2 MetroHealth clinics participate). Thus far, 353 referrals have been made to United Way 2-1-1 and 162 patients were reached and given referrals to community resources. Of these referrals, the top 5 need categories identified thus far include food (n=127; 79%), physical activity (n=124; 78%), health care (n=70; 44%), housing (n=31; 19%), and utility assistance (n=25; 16%).
- 4. Innovative ways to enhance smoking cessation efforts in primary care. MetroHealth CHRP Site PI Seeholzer in collaboration with OHSU investigator Flocke were awarded an American Cancer Society grant to test a systems change intervention at MetroHealth primary care clinics for

- smoking cessation that compares electronic referral by primary care support staff to the 1-800-Quitline (cessation counseling and nicotine replacement) versus a referral to a Choose2Quit Tobacco Cessation Navigator who offers a variety of quit supports in addition to counseling, (i.e. nicotine replacement, medication, and addressing social determinants of health).
- 5. Workforce development to improve quality and reduce burnout in primary care. CHRP Investigator Dr. Caron has two workforce primary care training grants in 2019 which have engaged 55 primary care team members (45 at MetroHealth). In a subset of 14 providers who completed the program, providers indicated they were more likely to remain at the institution, were more satisfied with their jobs, and experienced less burnout. There was less than a 0.5% decrease in overall productivity equaling a total average annual program cost in lost clinical revenue of ~\$12,000 for 14 participants (<\$1000 per participant). Participants progressed professionally assisting in MetroHealth system efforts: one of the scholars was promoted to Program Director in Family Medicine; one was promoted to Medical Director, Quality and Institute for H.O.P.E.™; and one was promoted to the Institutional Leader in Data-driven quality improvement. The total number of peer reviewed publications produced by the faculty scholars increased from zero in the two-year period prior to enrollment to nine in the three years of the program. National meeting presentations increased from 11 to 30. Additionally, Dr. Caron assisted NEOMED with developing a similar program for rural faculty and serves as the site PI for their grant.
- 6. Understanding how neighborhood social contexts influence cardiovascular risk. CHRP Investigator Dr. Perzynski and Dr. Dalton (CHRP Senior Scholar at Cleveland Clinic) co-direct a National Institute on Aging funded study, "Modeling and Forecasting Atherosclerotic Risk: A Complex Systems Approach" that is utilizing electronic health record (EHR) data in a first-of-its-kind regional, population-derived registry to understand how neighborhood social contexts influence cardiovascular risk across the life course. The NEOCARE Learning Health Registry includes data collected from 1999 to 2019 on more than 3.1 million unique individuals, diverse by race and ethnicity in Northeast Ohio. Selected published studies have examined the structure of social factors and life expectancy (Perzynski et al, 2020), neighborhood circumstances and lung cancer (Adie et al., 2020), homelessness and the burdens of comorbidity and mortality (Bensken et al., 2019; Rothberg et al, 2020), and gaps in prediction of cardiovascular disease for the oldest older adults (Dalton et al, 2020).
- 7. CHRP Investigators have been active in evaluating efforts of the MetroHealth Transformation. As MetroHealth undergoes construction of a new hospital structure and campus, the Clark-Fulton neighborhood will concomitantly undergo transformation as the world's first ever healthcare system-anchored EcoDistrict. Utilizing a novel data collection approach with pilot funding from the Robert Wood Johnson Foundation, Dr. Perzynski and PHRI Postdoctoral Scholar Dr. Kristen Berg collected qualitative data with 19 referral-sampled adults in the Clark-Fulton area in English and Spanish to better understand neighborhood residents' perspectives and priorities for community health. This research work sought to align the goals of MetroHealth's healthcare system-initiated community improvement effort with the perspectives and needs of Clark-Fulton residents and included a collaboration with the Transformation team, the Institute for H.O.P.E.<sup>TM</sup>, the City of Cleveland and The Metro West Community Development Corporation. Findings revealed health priorities distinct from traditional clinical outcomes, with residents

emphasizing social connectedness, competing intra- and inter-neighborhood perceptions that lead to isolation and reduced well-being, and a powerful linkage between neighborhood conditions and resident feelings of self-worth. In early 2020, this research was featured at the EcoDistricts Annual Meeting, the National Association of City and County Health Officials, and the All In Data for Community Health National Meeting. The investigative team is nearing completion of a letter of intent to the Robert Wood Johnson Foundation Evidence for Action grant mechanisms to support the development of a data and evaluation framework for the EcoDistrict in Cleveland and other EcoDistricts around the United States.

- 8. Community-based trial to improve pain and quality of life after breast cancer treatment. Agrant entitled "Pain and Immobility After Breast Cancer Surgery: A Community-Based Randomized Controlled Trial of Myofascial Massage Treatment." led by CRHD Director Dr. Sehgal supports a community-based, randomized controlled trial involving 202 women with persistent pain and mobility limitations after breast cancer treatment. Participants in each group will receive 30 minutes of treatment twice weekly for two months. The treatment group will receive massage therapy while the control group will receive light touch therapy. Primary analyses will determine the impact of myofascial massage on pain and mobility limitations. Secondary analyses will examine the impact of myofascial massage on several outcomes, including range of motion, quality of life, sleep, and body image.
- 9. Addressing asthma symptoms in disadvantaged populations. Among over a dozen different externally funded collaborative grants with CCIRE Director Kaelber as Site PI, one particular grant highlight is the 5-year multi-center PCORI Patient-Activated Reliever Triggers inhaled corticosteroid (PARTICS) grant. This grant investigates the use of existing asthma medications but used in new ways to be more effective and also allows medication self-titration in moderate and severe asthma minority (African-American and Hispanic) patients. From a research perspective, this study has been notable for the following: a) Patient recruitment powered by informatics tools, MetroHealth has been a lead site in the national in terms of MetroHealth's ability to identify and recruit minority patient for this study; b) Patient questionnaire completion this study serves as a national model for how to obtain over 90% compliance with monthly remote patient symptom survey completion; and c) Asthma outcomes preliminary results show that PARTICS significantly reduces symptoms, emergency department visits, and hospitalization among minority patients with moderate or severe asthma.
- 10. Collaborations with CWRU to enhance research. MetroHealth PHRI investigators collaborate on the CWRU Clinical and Translational Science Center (CTSC) award by providing informatics, study design and statistical analysis plan support for researchers applying for federal funding. CHRP investigators led by Dr. Gunzler provided 62 consults in 2019 for study design and statistical support. CCIRE Drs. Kaelber and Tarabichi provided dozens of research informatics consults and supported use of "big data" tools including IBM Watson Health's Explorys, Epic's Slicer-Dicer, TriNetx (went live for MetroHealth in 2019) and Epic's Cosmos Data Network. These tools are used for thousands of queries per year and result in dozens of grant opportunities, abstracts, presentations, and publications annually.
