PHRI 2022 ANNUAL REPORT EXECUTIVE SUMMARY

In 2022, PHRI entered a second year of implementing our 2020 strategic plan to meet our shared mission of leading the way to a healthy, thriving, equitable community and nation through actionable research, education and collaboration. In 2022, PHRI faculty held **34 active grants** where our ~16 core faculty serve as PI, co-PI or site PI totaling over **27 million dollars (increased from 27 grants and 17 million dollars in 2020) with 8 new grants in 2022 (see 2022 PHRI Grants Table).**

Selected examples of <u>newly funded grants in 2022</u> include:

1) \$3 million dollar 3-year HRSA grant to upskill and train over 240 Community Health Workers in the region (PIs Davis/Caron)

2) \$1 million dollar 3-year NIH grant evaluating the effectiveness of a wearable hydration device (Pls Johnson, Piktel, Roach)

3) \$400,000 NIH CLOCK Consortium for PASC Phase II RECOVER Pediatric Cohort (Kleinman – PI; Kaelber – Site PI)

4) \$500,000 Ohio Department of Medicaid 1-year Planning Grant to establish a Northeast Ohio Quality Improvement Hub (Konstan, Bolen – Pls)

PHRI faculty also continued to serve as co-Is on **21 collaborative grants bringing in an additional 23 million dollars**. We also began our 2nd year of the PHRI pilot grant program to provide seed funding for collaborative population health research focused grants in 2022.

Beyond funded grants and projects, we continued to grow faculty and build collaborations in 2022 to assist in meeting our mission. We invited an additional 4 collaborating faculty (bringing our <u>total collaborative faculty to 50</u>) to join with us from across the region. We continued our monthly community-based research network meetings, and maintained relationships with our <u>over 40 community partners</u>. We hired 1 new investigator (Berg) focused on neighborhood social determinants of individual and family health across the life course. We also continued our 2nd year of the PHRI research fellowship, with 2 new research fellows for the program in 2022.

PHRI faculty continued to disseminate their work to enhance the regional and national reputation of The MetroHealth System and Case Western Reserve University (CWRU). We continued to increase our <u>publications to 90 in 2022</u> (from 38 in 2019 and 58 in 2020) around key topic areas such as COVID-19, health disparities, cardiovascular health, and informatics research (see **2022 PHRI Publication List**). Our faculty were <u>invited to provide ~20 national presentations in 2022</u> (see **2022 PHRI Invited National Presentations**), with more than 50 other regional and national presentations in 2022 highlighting PHRI activities (see **2022 PHRI Abstracts/Conference Talks List**). We also continued our PHRI Annual Visiting Professor Series around population health and our Annual Duncan Neuhauser Lecture Series around quality improvement. PHRI faculty mentored over 65 trainees in 2022 on population health focused research including around 20 residents and faculty from The MetroHealth System and over 20 CWRU students (see **2022 PHRI Trainees Table**). In addition to mentoring trainees, we continued to teach high profile courses at CWRU, including but not limited to the following: 1) Design and Analysis of Observational Studies led by Dr. Love, PHRI Director of Biostatistics and Data Sciences; 2) Introduction to Clinical Research Scholars Program led by Dr. Einstadter; 3) Climate Change and Health led by Dr. Sehgal; and 4) Qualitative and Mixed Methods in Public Health led by Dr. Perzynski. We continue to assist in teaching Block 1 and 3 CWRU medical students. Our PHRI faculty have had several awards, honors and promotions in the past year based on their work (see 2022 PHRI Honors, Awards, and Promotions List). Lastly, PHRI faculty have filled over 100 critical service roles nationally and regionally, including service roles within MetroHealth, within CWRU, and within the community (see **PHRI Service Roles List 2022**). We look forward to future activities in 2023.
