POPULATION HEALTH AND EQUITY RESEARCH INSTITUTE (PHERI) 2024 ANNUAL REPORT EXECUTIVE SUMMARY

In 2024, The MetroHealth Population Health and Equity Research Institute (PHERI) began developing a new Strategic Plan to meet our shared mission of leading the way to a healthy, thriving, equitable community and nation through actionable research, education and collaboration. Our 3 Centers [Center for Health Care Research and Policy (CHRP); Center for Health Equity, Engagement, Education, and Research (CHEEER); and the Center for Clinical Informatics, Research, and Education (CCIRE)] came together in August 2024 with collaborators to prioritize 3 areas for further enhancement: 1) alignment with MetroHealth and regional population health priorities; 2) Workforce development and diversity; and 3) Infrastructure. We will be developing an implementation plan for these areas in early 2025. In 2024, PHERI faculty held **37 active grants** where our ~17 core faculty serve as PI, co-PI or site PI totaling over **50 million dollars (increased from 17 million dollars in 2020, and 31 million dollars in 2023) with 8 new grants in 2024 (see 2024 PHERI Grants Table)**. PHERI faculty also serve as co-Is on **29 collaborative grants bringing in an additional 26 million dollars**.

Several key newly funded grants in 2024 include:

1. Dr. Ash Sehgal, with his team consisting of CHEEER faculty, Dr. Ther Aung and former CHEEER pilot awardee, Dr. Maeve MacMurdo (Cleveland Clinic), were awarded a 3-year \$17.2 million grant from the Environmental Protection Agency titled *Asthma, Indoor Air Pollution, and Greenhouse Gas Emissions*. The grant will replace gas with electric stoves and provide electric car outlets in homes of 1,200 people with asthma in Northeast Ohio.
2. The National Institutes of Health awarded a five-year, \$3.5 million grant entitled *Improving Sleep in African American Couples* to Dr. Daryl Thornton, Director of CHEEER, to support a couples' intervention to improve sleep apnea.
3. CHEEER Faculty Dr. Susan De Luca and collaborators at University of Southern California were awarded two separate R21 grants to better understand mechanisms of upstream prevention of suicide in high-risk adolescent populations.
4. The Western Reserve Land Conservancy, with MetroHealth CHRP Faculty Dr. Kristen Berg and Dr. Adam Perzynski as Evaluation Site Leads, was awarded a four-year \$2.4 million grant from the Office of Minority Health titled *Restoring Health Equity and Resilience to Cleveland Through Vacant Land Improvements*. The grant plans to examine the impacts of improving vacant land through ongoing cleaning and greening of several Cleveland neighborhoods on the cardiovascular health of residents in these neighborhoods.
5. CCIRE Faculty Dr. David Kaelber and Dr. Yasir Tarabichi were contracted by the Centers for Disease Control to collaboratively conduct vaccine and viral assay

health services research in Epic's Cosmos, in conjunction with two CWRU collaborators (Pauline Terebuh and Quangqiu Wang).

Beyond funded grants, we continued to grow faculty and build collaborations in 2024 to assist in meeting our mission. We welcomed 1 new investigator (Dr. Ashley Hughes) within CCIRE focused on informatics, team-based care, cancer and human-centered design. We grew our collaborating faculty (from 45 to 55). We continued our monthly community-based research network meetings and grew relationships with over 60 community partners (up from over 40 in 2023). We held a [Community Research Dissemination Day](#) on the theme of "Highlighting our Health Equity Research Heroes" with over 60 attendees in April 2024 at the LGBT Community Center of Greater Cleveland.

PHERI faculty continued to disseminate their work to enhance the regional and national reputation of The MetroHealth System and Case Western Reserve University (CWRU). We continued to increase our publications to over 160 in 2024 (from 38 in 2019, 58 in 2020, and 129 in 2023) around key topic areas such as health equity, social drivers of health, chronic conditions, disease prevention, health behaviors and health informatics (see **2024 PHERI Publication List**).

A book was also published in 2024 by MetroHealth collaborating faculty **Dr. Adebambo** with CHRP Faculty **Dr. Perzynski**, entitled [Racism, Microaggressions, and Allyship in Health Care: A Narrative Approach to Learning.](#) Several CHRP and collaborating

faculty (**Berg KA, Caron A, Singh MK, Watts B**) assisted in writing book chapters. The book is an edited collection of real experiences and strategies for promoting health equity. The book provides students and health care professionals an opportunity to hear from doctors, nurses, and health care administrators about how they can create a healthier more egalitarian workplace.

Our faculty were invited to provide ~20 national presentations in 2024 (see **2024 PHERI Invited Presentations**), with more than 100 other regional and national presentations in 2024 highlighting PHERI activities (see **2024 PHERI Conference Talks and Abstracts List**). We also continued our PHERI Annual Visiting Professor Series around population health and our Annual Duncan Neuhauser Lecture Series around quality improvement.

Our PHERI faculty mentored over 90 trainees in 2024 (up from 65 in 2020) on population health and equity focused research including around 20 residents and faculty from The MetroHealth System and over 40 CWRU students (see **2024 PHERI Research Trainees Table**). In addition to mentoring trainees, we continued to teach high profile courses at CWRU, (see **2024 PHERI Courses, Course Lectures, and Workshops List**), including but not limited to the following: 1) Design and Analysis of Observational Studies led by Dr. Love, PHERI Director of Biostatistics and Data Sciences; 2) Introduction to Clinical Research Scholars Program led by Dr. Einstadter; 3) Qualitative and Mixed Methods in Public Health led by Dr. Perzynski; 4) Climate Change and Health led by Drs. Sehgal and Aung; and 4) Computing in Biomedical and Health Informatics led by Dr. Kaelber. We continue to assist in teaching Block 1 and 3 CWRU medical students. Our PHERI faculty have had several awards, honors and promotions in the past year based on their work including community partnership and mentorship awards as well as top ranked national abstracts (see **2024 PHERI Honors, Patents, Awards, Milestones and Promotions List**). Lastly, PHERI faculty have filled over 100 critical service roles nationally and regionally, including service roles within MetroHealth, within CWRU, and within the community (see **PHERI Service Roles List 2024**). We look forward to future activities in 2025.
